THE VIRTUAL HASIOR'S RUN REGULATIONS

Organizer – The Tatra Museum of Dr. Tytus Chałubiński in Zakopane

Media Patronage - Radio Kraków, TVP3 Kraków, Tygodnik Podhalański, Watra Infogram, Zakopane.pl

I. OBJECTIVE

- 1. Celebrate Władysław Hasior's artistry and his passion for sports.
- 2. Promote running and walking as the most accessible form of exercise.
- 3. Encourage physical activity and a healthy lifestyle.
- 4. Explore Zakopane and its history.

II. DATE, ROUTE, AND DISTANCE

The run will take place **October 2nd through 16th 2022**. Participants all over Poland (and the world) can participate in the Hasior's Run, so long as they run a distance of **5 kilometers** (3.1 miles).

- 1. The run is individual and virtual. There will be neither a start nor finish line for participants to meet at. Every participant decides on their own where to start and finish the run. Each competitor takes responsibility for their own run.
- 2. The participants have full discretion in choosing the place for their run.
- 3. The run may be completed by runners alone or with family and/or friends, however competitors are asked to maintain social distancing and complete the run according to their local guidelines.
- 4. Competitors are obliged to take all precautions during their run.
- 5. Competitors shall determine the route of the race themselves in accordance with applicable regulations (including traffic laws, civil codes, and land regulations) and necessary safety measures for the area in which they are currently staying.
- 6. The organizer reserves the right to cancel the event in the case of unexpected circumstances or due to reasons beyond the organizer's control.

III. LIMITS AND TIMING

- 1. The competitor may decide whether to walk or run the chosen route.
- 2. The competitor determines the logistics of the race themselves, including the route of the race, the time, and the start and finish lines.
- 3. Competitors cover the route by running or walking. It is acceptable to run with a pram, use nordic walking sticks, use guided running, and run with a pet.
- 4. Each competitor will register their run with a commercially available running application(e.g. MapMyRun, Strava, Runkeeper) with a GPS function, registered on a mobile device. If possible, competitors will be asked to upload a photo or screenshot of their route.
- 5. After the completed run, competitors **must enter their results into the Hasior's Run application found on www.muzeumtatrzanskie.pl**. Competitors will also document their result by means of a screenshot from their running application or a photo from a sport watch with a GPS function. Time and distance must be visible in the photo. A completed run shorter than 5 km will not be taken into account in the final results. Sent results will be verified for accuracy.

6. Each competitor must enter their result no later than 11:59 PM Central European Time (CEST) on October 16th, 2022.

IV. PARTICIPATION TERMS AND CONDITIONS

- 1. Participants must register on www.muzeumtatrzanskie.pl by October 14th, 2022.
- 2. Children and adolescents may participate in the run only under the supervision of adults.
- 3. Minors must be registered and paid for by their parental guardian.
- 4. Parental guardians are fully responsible for the participation and safety of their minor(s) throughout the run.
- 5. After registering and paying the participation fee (if applicable), competitors will receive a bib number as a PDF file, which can be printed and attached to a t-shirt during the race. (optional)
- 6. Competitors may not use bicycles, roller skates, skateboards, skis, scooters, or other mobility vehicles while running.
- 7. Each competitor, accepting the race regulations (by means of an activation link sent to the email address given in the Application Form), declares that he or she is aware that the Organizer does not take responsibility for any damages and consequences of accidents that may occur during the run.
- 8. The Organizer does not provide participants with accident insurance or any snack supplies.

V. STARTING FEE

- 1. Registration for Hasior's Run will take place by means of an application form ("Application Form") available on www.muzeumtatrzanskie.pl.
- 2. The deadline for registration is October 14, 2022 at 8:00 PM CEST.
- 3. Registration includes completing the online Application Form (requiring name, address for delivery of the starter pack, and details of the competitor). By registering, the competitor automatically accepts the run's regulations.
- 4. Competitors may pay a one-time non-refundable fee to receive the starter pack. If the event is cancelled for reasons beyond the organizer's controlled, this fee will be refunded.
- 5. Participation in the run without the starter pack is **free**. Each competitor registered will receive a number and diploma to print themselves at no charge.
- 6. The starting fees are as follows:
 - a. **40 PLN** includes a starting number, diploma to print, medal, running t-shirt to be collected at the Tatra Museum, ul. Droga na Koziniec 8, 34-500 Zakopane
 - b. **50 PLN** includes a starting number, diploma to print, medal, running t-shirt that will be shipped within Poland
 - c. **60 PLN** includes a starting number, diploma to print, medal, running t-shirt that will be shipped within Europe
 - d. **70 PLN** includes a starting number, diploma to print, medal, running t-shirt that will be shipped worldwide
- 7. The starting package can be collected at the headquarters of the organizer (the main building of the Tatra Museum, ul. Krupówki 10 8, 34-500 Zakopane) from October 24, 2022 through November 04, 2022 between 8 AM and 3 PM.
- 8. Competitors who opt to receive the starting package by mail must complete the shipment details in the application form.

- 9. T-shirts and medals will be sent within two months after Hasior's Run ends for shipments within Poland and up to three months for worldwide shipments.
- 10. In the case of a competitor not collecting their starting package due to an absence or any other reason that it returns to the organizer, the recipient of the shipment must cover the costs of delivery.

VI. CLASSIFICATION

- 1. Competitors will be classified according to gender and the following age categories:
 - a. Junior W/M up to 16 years old, born in 2006 and later
 - b. **Senior W/M** up to 39 years old, born in 1983-2005
 - c. **Masters W/M** 40-49 years old, born in 1973-1982
 - d. **Veteran I W/M** 50-59 years old, born in 1963-1972
 - e. **Veteran II W/M** 60-69 years old, born 1953-1962
 - f. **Super Veteran** 70+ years old, born 1952 and earlier
- 2. The Organizer will post some photos from participants on the Organizer's Instagram and/or Facebook.
- 3. The Organizer reserves the right to introduce additional categories.
- 4. All results will be published

VII. PERSONAL DATA PROTECTION

- 1. Personal data of participants will be processed in accordance with the applicable provisions, in particular Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation).
- 2. Processing of data mentioned in point VII.1. also includes the publication of: name, surname, date of birth, city and name of the club.
- 3. Detailed information about processing of personal data is included to Annex 1 to this Regulations.
- 4. The participant has the right to request: access to their personal data, correction, removal and restriction of their processing. In addition, he/she has the right to object to the processing and transfer of their information.
- 5. Providing personal data and acceding to process them is voluntary, however if participant does not agree to provide and publish them they cannot take part in the run.

VIII. FINAL PROVISIONS

- 1. All participants of the Hasior's Run are bound by the regulations as outline in this packet. By submitting an application, the participants declare that they have read and accepted the regulations and agree to uphold the provisions. Each competitor starts in the race on their own responsibility.
- 2. The Tatra Museum has the exclusive right to make a binding interpretation of the provisions of these regulations, to resolve disputes and doubts arising during their application and to answer questions concerning their content.
